



## **2015 SPRINTCAR PRESIDENTS CUP**

Avalon Raceway presents the 2015 Presidents Cup to be conducted on Wednesday the 21st of January 2015

Attached is the terms and conditions of entry, format, prize money and nomination form.

### **Entries must be in by Friday the 9<sup>TH</sup> of January 2015**

Drivers that nominate on time will receive tow money plus driver and one crew admissions free. (Driver & Crew Names must printed on the nomination form)

### **Conditions of Entry**

**All competitors must have a current Sprintcar Control Council of Australia Competition licence** all Sprintcars are to be SCCA registered, racing is conducted as per the current SCCA Racing Rules, Regulations and Specifications. Competitor will also be required to have a current and valid **Speedway Australia Licence card**.

**Noise Level 95 dba**. Effective type mufflers must be used (Sprintcars with any straight through Knoxville type muffler will not be started under any circumstances)

**All Speedway Australia OH&S Pit rules and safety conditions apply at all times**

### **FORMAT – Based on a forty sprintcar field.**

**In the event of 41 or more nominations the format will refer to a qualifying and one heat format** (See next page for qualifying and one heat format)

### **FORMAT ONE - for up to 40 nominations.**

Time Trials 2 cars, 2 laps via transponders  
Fastest 30 qualifies to heats (10 Laps)  
Remainder of entrants to non qualifiers races (12 laps)

**Non Qualifiers race**, the first six car transfer to the rear of both heats per car.  
1<sup>st</sup> to p11 heat 1, 2<sup>nd</sup> to P11 of heat 2, 3<sup>rd</sup> to P11 heat 3, 4<sup>th</sup> P12 heat 1 etc

**HEATS** – Three heats per round -The first round of heats will be determined by a (top 10 inversion) with the fastest qualifier to Position 10 of heat 1, second highest qualifier to position 10 of heat 2 etc.

The second round of heats will be determined by inverting the first round draw and moving rows to different heats. Transferring cars from the non qualifiers will stay at the rear of the heats.

**HEAT POINTS:** 1st – 12, 2nd – 11, 3rd – 10, 4th – 9, 5th – 8, 6th – 7, 7th – 6, 8th – 5, 9th – 4, 10th – 3, 11th – 2, 12th – 1.

To split any cars on equal points the car that has recorded the fastest lap during time trails, using the transponder system, will be deemed the higher qualifier.

Top 14 qualifiers after heats to A Main,

Qualifiers from position 15 thru to 30 to B Main. First 4 in B Main to rear of A Main.

B Main – 16 cars (15 Laps)

A Main – 18 Cars (25 Laps)

## **FORMAT 2 - 41 Nominations or more.**

This will be a Time Trial and a one heat format.

Drivers will be seeded then drawn to determine their hot lap / qualifying session.

Drivers must hot lap and qualifying in there dawn session, there will be qualifying points as per the heat points with fastest time receiving 12 points, second fastest 11 points and so on.

Each Hot lap / Qualifying session will carry the same points.

Once the drivers hot lap /Qualifying session is over there will be top six inversion for their heat race, fast time will start from P6, second fast time P2 and so on, qualifiers from seventh thru to twelfth place will line as per qualifying times from P7 to P12.

### **MAIN GRIDS**

**C Main – 16 cars** (12 laps) - **SUBJECT TO TIME** – 29<sup>th</sup> thru to 44<sup>th</sup>

**B Main – 16 cars** (15 Laps) - 15<sup>th</sup> thru to 28<sup>th</sup> on points + 2 From C Main

**A Main – 18 Cars** (25 Laps) - Top 14 on points + 4 From B Main

To split any cars on equal points the car that has recorded the fastest lap during time trails, using the transponder system, will be deemed the higher qualifier.

**FAST TIME** - \$200, **2nd FAST TIME** - \$100, **3rd FAST TIME** - \$75
