WESTERN SPEEDWAY HAMILTON Presents

The SRA OF Vic Inc Parr Motorsports 360 Victorian Sprintcar Title / GOLD CUP Saturday the 24th of March 2018

This event is open only to current SCCA registered 360ci Sprintcars as per the 360 Sprintcar specifications.

The Event will take place under the SCCA Racing Rules, Regulations and Specifications as set out in the current rulebook. All competitors must have a current SCCA competition licence and SCCA registered sprintcar. This venue also requires Speedway Australia Licence card.

FORMAT (No control tire for this event - rule as per SCCA book)

- Each driver to compete in two heat races of ten laps.
- First round of heats to be drawn at the drivers briefing with an inversion for the second round of heats.
- Each driver will have an inside row start and an outside row start, in the heats.
- Points attained through the heats will determine the qualifying position in the A or B-Main
- If you do not finish your heat, you do not get any heat points.
- Top 6 points qualifiers will **Time Trial** for their A Main start positions, Fastest qualifier has choice of start position 1 or 2
- Point scorers from 7 thru to 12 go direct into the A Main as per qualifying points in starting positions 7 to 12.
- Point's scores from 13 to 28 go into the B Main - 4 cars from the B Main transfer to the A Main.

To split any cars on equal points the car that has recorded the fastest lap during the heats using the transponder system, will be deemed the higher qualifier.

Western Speedway Hamilton in consultation with the state member club for Sprintcars (SRA of Vic Inc) reserves the right to add, alter or amend the format.

(Heat events are not to have less than eight sprintcars)

Heats 10 laps - B Main 15 laps - A Main 25 laps

Western Speedway Hamilton uses the AMB Transponder System for the purpose of lap scoring and timing. Hire transponders are available at a cost of \$30 incl. GST per night. Transponders not purchased through the System Operator at the venue will incur a service fee of \$15 incl. GST per night

NOMINATIONS for this event must be in by the no later than Sunday the 18th of March 2018 by 7pm please see nomination information on the next page. All nominations will only be accepted on the official nomination form.

Nominations

Nominations are to be nominated 6 days prior to the scheduled event by the **(18/03/2018 by 7pm)** on the official SRA nomination form (see attachment) Nomination cost is \$100.00 Inc GST plus \$4 admin per car. It is required that if you make your payment by cheque please make it out to: **(The Sprintcar Racing Association of Victoria Inc)** in full not SRA or supply credit card details on the nomination form. Faxed and posted nomination forms, accompanied with payment, must be with **The SRA of Vic Inc** within the specified time. **Postal delays are not accepted as an excuse**, please allow **eight working days** for postal service. Phone nominations will not be accepted under any circumstances. **On attendance nomination fees received on time by the (18/03/2018 by 7pm) will be reimbursed.** Late nominations will be accepted, the nomination fee remains at \$100.00 Inc GST plus \$4 admin fee, but no nomination fee will be refunded to that competitor nominated. If no nomination is received within 24 hours of the race meeting commencing, then the \$100.00 nomination fee can be paid in cash on the day of the race meeting, but the competitor will be starting rear of field in both heats. **Any driver whom nominates, but fails to attend the race meeting will forfeit his/her nomination fee, there are no exceptions.**

Scrutineering will commence at 2.30pm till 4pm (Sprintcar scrutineered after 4pm will have rear of the field starts in all there heats)

All scrutineering will be conducted in a designated area at the venue.

All safety gear, current Sprintcar Control Council of Australia Competition licence and log book must be presented at scrutineering with the sprintcar. Please ensure you have ready your logbook with SCCA license / infringement book stapled inside the front cover. (This venue may require a speedway Australia licence card)
