Postal delays are not accepted as an excuse. Phone nominations will be accepted provided full payment details are supplied at the time. On attendance **drivers that nominate 7 days prior to a scheduled series round will receive 30 bonus points to the total of that nights event and will have there nomination fee reimbursed.** Please note **(Nomination fee reimbursement will be excluding GST unless a tax invoice is supplied).** Late nominations will be accepted, but the nomination fee is then \$50 Inc GST. If no nomination is received within 24 hours of the race meeting commencing, then a late nomination fee can be paid on the day of the race meeting, but the competitor will be starting rear of field in both heats. (As per item 2 attendance / nominations of series regs)
